- 4. President's report (DB)

DB reported the following-

- The BSGE has renewed its corporate membership of ESGE and the Journal will now be open access, which will improve its impact factor but authors will face costs for publication. These will be covered by the ESGE for a set number of publication each year.
- The BSGE has signed a partnership agreement with the RCOG, which is mutually beneficial to both charities.
- The BSGE is working with the RCOG to improve the ATSM curriculae in Laparoscopy and hysteroscopy and higher specialist training in laparoscopy.
- The BSGE SICS has now been launched.
- The BSGE plans to build on the success of the Hands on training (HOT) sessions by becoming an examination and training centre for the ESGE Diploma in laparoscopic surgery.
- The BSGE will develop a worldwide membership package for affiliate members and put this to the membership and present it for agreement at the next AGM.
- DB grateful thanks go to Thomas Ind, Tyrone Carpenter, Gill Smith and Liza Ball who will be leaving council, for their hard work and dedication to the BSGE. They will remain on the subcommittee of their previous portfolio.

SV reported that upon instructions from Council SV and Alfred Cutner are working with the college on the content and the status of the advanced laparoscopic surgery ATSM which has evolved. A letter has been sent to Janice Rymer, Vice- President of Education on status of changing the ATSM to sub-specialty. This may take up to 18 months.

# 6. Honorary Treasurer's report (TI)

TI declared his disclosures to the meeting. TI received a consultancy payment from Medtronic, Trips & Hospitality from; Intuitive, Storz, Olympus, Covidien, Ethicon and Lotus. TI is Officer of the BSGE, BGCS, BIARGS, and SERGS.

Reserve policy- Minimum of three year's office costs (really four years) - £200,000 and two years ASM costs - £215,000.00.

Maximum of 80% of average income for a given year averaged out over 5 years (£360,000 averaged of last five year – Compliant). 2x the previous year's expenditure on charitable activity (About 2 x £325,000)

TI recommends some capital expenditure and employing another person to the incoming Treasurer.
